AGENDA DETAILS

Agenda topic: Call to Order, Pledge of Allegiance, Roll Call

Secretary Slater opened the meeting and brought it to order at 9:37 am.

Carrie Roth led us in the Pledge of Allegiance.

Deputy Secretary Nicole Overley called roll and quorum was not met, so cannot approve the minutes from previous meetings.

Agenda topic: Opening Remarks

Presenter: George "Bryan" Slater, Secretary of Labor

Summary of topic:

Thanked everyone for being here. Biggest announcement is congratulations to Commissioner Roth, members of the General Assembly, and Governor as we now have a live, new workforce agency as of July 1. Reviewed agenda items. Announced Workforce Summit on September 19. Had guests introduce themselves.

Agenda topic: The Latest from Virginia Works

Presenter: Commissioner Carrie Roth, Virginia Works (a.k.a. Department of Workforce Development and Advancement)

Summary of topic: Commissioner Roth recognized Intern Day and the various pathways people take to employment. Agency went live on July 1. Changes to SB 436 are now Virginia law. Reviewed key responsibilities of Virginia Works. Introduced Michael Peterson as Chief Information Officer.

Secretary Slater stopped to congratulate Commissioner Roth, Deloitte, and the teams it took to stand up the new agency, especially in this timeframe.

Commissioner Roth discussed new location and features of Holland Tower, including being able to hold VBWD board meetings. Move is expected to happen in October. Reviewed process improvement and sprints overview. Sprint 1 focused on monitoring and rapid responses; Brian Davis shared how they are addressing companies that are doing layoffs but not yet at the WARN level of 50. Discussed Reemployment Services and Eligibility (RESEA), which people will enter after receiving 21 days of unemployment benefits. Sprint 2 focused on Registered Apprenticeship; one win was leveraging technology, moving from paper to PDF. Automating work when possible. Sprint 2 also focused on Economic Information & Analysis (EIA) and Workforce Services (WFS). Sprint 3 is underway right now and focuses on Foreign Labor

Certification/ Migrant Seasonal Farmworker Outreach; Jobs for Veterans State Grants; Trade Adjustment Assistance (TAA). Sprint 4 is coming and will focus on Work Opportunity Tax Credit (WOTC), Data Analytics & Research – which is a new team within the agency, and WIOA Title I. Sprint 5 is coming and will focus on agency-wide and cross-sprint transformation to improve the agency. Focused on improving services for customers, having a customer-centric mindset. Discussed overall progress and accomplishments to date.

Agenda topic: Updates From Across Our Ecosystem

Presenter: Deputy Secretary Nicole Overley

Summary of topic:

Deputy Overley provided some quick updates on Metrics and Engagement since the last update. Continue to have active engagement from 100% of those involved. Continue to host virtual Town Halls. Refine the program catalog and issuing a new version in the fall. Will focus Sector Partnerships and Strategic Plan. Reviewed first reporting period data collection and discussed the reasons for variation in data across programs. Exploring different tools and validation to improve data collection, including by using the Workforce Data Trust.

Secretary Slater noted none of the programs are competing against each other. Endeavoring to have transparency and accountability. Deputy Overley discussed the Sector Partnership Playbook, developed in partnership with the Claude Moore Foundation. Dr. Bill Hazel added to the conversation. Playbook is 80 pages, including appendices. Broaden familiarity with this concept of sector partnership – team of people across organizations working together to prepare the workforce of today and the future. Each of the workforce board executive directors have contributed to the process.

Deputy Overley discussed the Statewide Workforce Strategic Plan, which includes four pillars – customer discovery, ecosystem mapping, skill & job data, and stakeholder input. Surveys have provided a wealth of data. Invited everyone to join an informal focus group. Making an effort to align with VEDP's Top State for Talent Goals – retain & attract talent, develop talent that is aligned to employer needs, and unlock individual potential by reducing barriers.
