AGENDA DETAILS

Agenda topic: Call to Order, Pledge of Allegiance, Roll Call

Secretary Slater opened the meeting and brought it to order at 10:08 am.

Deputy Secretary Nicole Overley called roll and quorum was not met, so cannot approve the minutes from previous meetings.

Agenda topic: Opening Remarks

Presenter: George "Bryan" Slater, Secretary of Labor

Summary of topic:

Thanked members who have stepped off. Gave an overview of the agenda and what topics will be covered today.

Agenda topic: The Latest from Virginia Works: The Transition, Our Services, and Process Improvement Efforts

Presenter: Director Carrie Roth, Virginia Works (a.k.a. Department of Workforce Development and Advancement)

Summary of topic: Reviewed the mission and vision. It's exciting to see the engagement and look forward to increased collaboration. Unemployment rate is 2.8% and labor participation is 66.4%. SB436 signed into law; reviewed the updates it covers. Reviewed services within Virginia Works, including transferred programs and new functions. Will officially have a budget and go live on July 1, 2024. It's taken a strong team effort to get to this point, including streamlined technology, Shared Services, and shift to new headquarters in Richmond. Focusing on continuous improvement and better use of technology. Businesses and customers are at the center of everything Virginia Works does. Virginia's employment penetration rate is two points below national average, which means we need to engage more employers. Discussed Registered Apprenticeship programs and the goal to double the number of programs. Expansion to add programs that don't fit RA program exactly. Consider nomenclature so we do not confuse people with RA program vs. alternatives. Discussed how are we reaching different populations.

Agenda topic: Working Together Across Our Ecosystem

Presenter: Deputy Secretary Nicole Overley

Summary of topic:

Deputy Overley discussed the evolution of the metrics journey and where we are in the process. Collecting six baseline data points from each program on a quarterly basis; have completed the first reporting cycle and nearing the end of the second reporting cycle. Continually refining and pleased with the level of engagement. Built a dashboard. Introduced the catalog, which will be continually updated and shared via a live PDF. Reviewed the collective impact of the programs. Discussed the workforce development ecosystem that serves individuals and businesses. Commonwealth Town Halls are continuing and well attended. Reviewed the upcoming meeting and quarterly progress reports.

Discussion highlights:

Opened the floor for questions. The importance of getting metrics. Suggestion: consider adding employers and program graduates to the Town Halls. Would like to hear more about how the vision is impacting delivery of services.
